- complying with the law, including do anything that we are required or authorised by the law to do;

- facilitating our business operations, including to perform other functions and activities relating to the business of Securitas and improve our services; and
- identifying and (unless you tell us not to) telling you about developments within the Securitas Group, our
  products and services, and those of third parties and other entities in the Securitas Group, that might

and for purposes otherwise set out in our Privacy Policy.

We may also disclose personal information, particularly of employees, as part of personnel management and reporting to regional operations in Singapore, and head office in Sweden as well as our data hosting and other service providers in Singapore, Belgium and United Arab Emirates.
